Dear Mr. Wolfman:

Regarding your letter of June 11, 1990:

- 1. Thank you for the free (presumably) legal advice to seek legal advice:
- a. With legal expenses that will already approach a half-million dollars this year, we really don't feel the need to make voluntary contributions to the Legal Aid Society.
- b. Neither do we need legal advice to respond to nuisance threats.
- 2. I am glad that you found my letter entertaining, but am sorry that you missed the "enlightening" parts:
  - a. We don't respond well to threats.
  - b. We don't settle when we are right.
- c. We exhibit a peculiar tenacity when we believe that we have been unfairly attacked. (See FALR, Volume XII, No. 7, front cover.)\*
- d. Our reputation, particularly in the areas of integrity, ethics and regard for individual dignity, is sufficiently strong and well-founded that it is not threatened by actions such as this.
- 3. I do not propose to spend my time attempting to disprove absurd assertions whose validity, like beauty, lies only in the eyes of the asserter (or beholder, as the case may be).

If, indeed, you have "facts" to prove their claims, then present them and prove us wrong. Until such time, we will continue to believe that we have wronged no one in this matter and will continue to act accordingly.

Be careful, however, of your "facts". They can be devilish little creatures and have been known to change size, shape and color when closely examined. Sincerity is a commodity more readily producible than <u>facts</u>.

4. I apologize if the whimsical nature of my reply suggested to you that we do not regard this sort of thing seriously. Normally we do. However, these claims are so remote from reality that it is difficult even to discuss them in a serious tone of voice.

I am tempted to reciprocate and offer you some free advice, but you would likely consider it patronizing, and, in any event, you will now do whatever you deem appropriate anyway.
